Will Rajasthan reduce electricity tax on solar energy?

Rajasthan would provide concession in stamp duty and land tax duty to renewable energy developers planning to set up projects in the state. Gehlot said that this would result in a reduction in electricity duty on solar energy from INR0.60 (~\$0.007)/kWh to INR0.40 (~\$0.005)/kWh, which is expected to benefit residential net metering consumers.
